



Anthony E. “Tony” Watson Director of Acquisition Management

Anthony E. “Tony” Watson is Director of Acquisition Management for the Defense Commissary Agency, with headquarters at Fort Lee, Va. He is responsible for the oversight of the agency’s contracting mission in support of nearly 240 commissaries worldwide.

Mr. Watson leads an acquisition workforce of over 140 employees who procure a wide variety of commodities and services, including commercial activity services, supplies, equipment, architect-engineer services, construction, resale, and information technology, as well as contracting policy and e-business systems. Total acquisitions for the agency are nearly \$5 billion annually.

Mr. Watson retired from the U.S. Air Force in 2006, after serving 22 years in several acquisition-related fields including inventory management, logistics management and contracts management.

His prior military service also included experience in resource and budget management. During his Air Force career, he served in regular and classified assignments at multiple stateside locations, in Europe and the Middle East beginning in the contracting career field in 1991. His last active duty assignment was at the 1st Contracting Squadron, 1st Fighter Wing, Langley AFB, Va., as the infrastructure flight superintendent.

After retiring from active duty, Mr. Watson immediately began his federal civil service career in contracting with the U.S. Army at Fort Eustis, Va., working for a DOD joint command, U.S. Special Operations Command (USSOCOM). As a team lead responsible for the life-cycle contracting for the U.S. Army Special Operations helicopter fleet, Mr. Watson’s duties also included the agency/organization program coordinator (A/OPC) for the Government Purchase Card (GPC), the Small Business Professional (SBP) and as a career field manager (CFM).

Mr. Watson left the U.S. Army in 2015 and went to work for the U.S. Navy in June 2015 for the Naval Sea Systems Command (NAVSEA) co-located at Newport News Shipbuilding. During his tenure as a division head in the contracting department, he oversaw administration of numerous multi-billion dollar contracts for the Navy’s nuclear aircraft carrier fleet Refueling Complex Overhaul (RCOH) program, nuclear attack submarine repair and availabilities, and the construction of the Navy’s newest nuclear attack submarine programs.

Mr. Watson joined DeCA in June 2020 after acquiring 29 years of contracting experience in multiple DOD agencies to include participation on the 2013 DoD Procurement Management Review (PMR) Team for Defense Procurement and Acquisition Policy (DPAP) conducting contract program reviews and compliance inspections. He brings a wealth of acquisition knowledge to the agency in all types of contracts, procurement of varying types of requirements and unique acquisition methods.

Mr. Watson has been a member of the National Contract Management Association (NCMA) since 1999. He has completed all acquisition Level 400 courses through the Defense Acquisition University (DAU) and is a DOD-certified Acquisition Professional in Contracting – Level III under the Defense Acquisition Workforce Improvement Act (DAWIA). He is also a certified member of the DOD Acquisition Corps.
